**Consultation on admission arrangements for 2027/28 (2026 determination year)**

I am writing to notify you of the upcoming consultation on DNEAT's admissions policy. The consultation period will run from **31 October 2025** until **14 December 2025**; during this time, members of our community are invited to express their views and any concerns about the proposed changes to the admission arrangements.

In accordance with the DfE's 2021 statutory 'School Admissions Code' guidance, as an admissions authority we must consult on our admission arrangements at least once every seven years, and when changes are made, other than rolling forward dates and deadlines for the admissions process. You can see the proposed admissions policy online at [www.dneat.org](http://www.dneat.org) including a list of the proposed changes.

In accordance with the DfE's 2021 statutory 'School Admissions Code' guidance, as an academy we must also consult if we wish to reduce the PAN (Planned or Published Admission Number) of an academy. The PAN is the maximum admission number for the academy. A list of proposed PAN reductions in DNEAT academies is included with this letter and can be viewed online at [www.dneat.org](http://www.dneat.org).

In accordance with statutory DfE guidance, the consultation will run for six weeks and, as an interested party at a DNEAT academy, we are keen to hear your views on the proposed changes; therefore, we invite you to participate in the consultation if you have any concerns regarding the matter.

All responses to the consultation should be made in writing and submitted **before midnight on 14 December 2025** to:

Please note that written responses should outline your personal details, including your name, address and relationship to the school.

At the end of the consultation period, the Trust will consider the responses. The outcome of the consultation will be published on the Trust website as soon as possible following a decision being reached by the Trust.
